### FINANCIAL REPORT

Mr. Proud asked OVRDC Treasurer, Doug Corcoran to present the Financial Report. Mr. Corcoran advised he was very pleased to report that we have completed our single audit process in compliance with OMB Circular A-133 with the new Independent Public Accounting (IPA) firm, Whited Seigneur Sams & Rahe, LLP. He indicated there were no findings or questioned costs. The firm will be conducting the annual audits through December 31, 2010. Mr. Corcoran also said the independent auditor's Report for the audit period January 1, 2008 through December 31, 2008 has been accepted by the auditor of the State and a copy of the report can be found on their website.

Mr. Corcoran expressed his appreciation for the working partnerships we have with the following federal and state grantor agencies: Appalachian Regional Commission (ARC); U.S. Department of Commerce under their Economic Development Administration (EDA) Program; USDA Rural Development; Governor's Office of Appalachia (GOA); Ohio Department of Development (ODOD), and Ohio Public Works Commission (OPWC).

In closing, Mr. Corcoran thanked our 12 member counties for their assistance in helping make a difference, and to keep up the good work and that he looked forward to the continuing partnerships in 2010.
